- 2. For the last 5 years please provide the number of patients that absconded from wards and which wards these were.

(absconded – a inpatient that has left a ward without informing a staff member, making them a missing person)

- 3. In the last 5 years on average per year, how much has the Trust paid out in compensation claims in relation to absconds from a ward?
- 4. Does the Trust have a Falls Group that meet to discuss fall reduction strategies for inpatients? If yes, how often do they meet?
- 5. Can you please identify the Lead Nurse in overall charge of the Falls Group?
- 6. Please can you provide contact details for the Staff Member in the public domain identified in question 5?

- 8. Could you please identify the company that supplied the equipment and the product supplied?
- 9. Is there a contract in place from a company that has supplied the Trust with falls equipment?
- 10. If yes, what company and when does this come to an end or is up for renewal?
- 11. Can you out line the procurement procedure for a company providing a free demonstration of Falls Equipment?

- 8. Montcalm International Ltd: OOKF Ook snow falls prevention low bed with built in exit alarms and class 3 scales

Montcalm International Ltd:OOKALL Ook snow low profiling bariatric scale bed (not 100% sure this comes under falls management however it is a low bed) purchased via NHS SC catalogue.

Sensor Care: falls monitor chair plates and bed plates

- 9. There are no contracts in place. The purchases for the beds have been made against the NHS SC framework or via their catalogue and maintenance for the beds and sensor equipment is completed in house.
- 10. No contract as above
- 11. This is usually instigated by the end user or the need for replacement equipment (new standard).

If this is requested by the end user then there is an internal form to be completed which completes a workflow of approval through the Care Group, Procurement and the Medical Devices Group. The demo is then managed by the Change Team. Representatives need to register on the MIA system to arrange an appointment if coming on site.

If this is instigated by the need for a new standard the demo would be arranged usually off the back of a competitive process run by the contracting team and managed by the Change Team
