^{*}Please note that levy-paying employers have 24 months in which to spend the funds available to them before they begin to expire on a rolling, month-by-month basis. Expired apprenticeship levy funds are not lost but are used to support apprenticeships in smaller employers and to cover the ongoing costs of apprentices already in training.

We are unable to provide the response to this question as to do so would exceed the appropriate time limit as set out in Section 12 of the Freedom of Information Act.

Under Section 12(1) of the Freedom of Information Act 2000 (FOIA), we are unable to comply with your request as the cost of responding to all parts would exceed the appropriate cost limit of £450 for NHS bodies. The £450 limit is reached by using a standard charge-out rate of £25 an hour, which equates to 18 hours' work.

Application forms for apprenticeships are currently paper based and to obtain the information for this response would involve reviewing 387 records to identify the sex of each apprentice. This would only allow two minutes per record to locate, review and note the information.
